Definitions

- 1.1 "SIA" means Sport Image Australia Pty Ltd, its successors and assigns or any person acting on behalf of and with the authority of Sport Image Australia Pty Ltd.
- 1.2 "Client" means the person/s (and where applicable a Distributor as per clause 3) buying the Goods as specified in any invoice, document or order, and if there is more than one Client is a reference to each Client jointly and severally.
- 1.3 "Goods" means all Goods or Services supplied by SIA to the Client at the Client's request from time to time (where the context so permits the terms 'Goods' or 'Services' shall be interchangeable for the other).
- 1.4 "Price" means the Price payable (plus any GST where applicable) for the Goods as agreed between SIA and the Client in accordance with clause 6 below.
- 1.5 "GST" means Goods and Services Tax (GST) as defined within the "A New Tax System (Goods and Services Tax) Act 1999" (Cth).

2. Acceptance

- 2.1 The Client is taken to have exclusively accepted and is immediately bound, jointly and severally, by these terms and conditions if the Client places an order for or accepts delivery of the Goods.
- 2.2 These terms and conditions may only be amended with the consent of both parties in writing, and shall prevail to the extent of any inconsistency with any other document or agreement between the Client and SIA.
- 2.3 The Client acknowledges that the supply of Goods on credit shall not take effect until the Client has completed a credit application with SIA and it has been approved with a credit limit established for the account.
- 2.4 In the event that the supply of Goods request exceeds the Clients credit limit and/or the account exceeds the payment terms, SIA reserves the right to refuse delivery.
- 2.5 The Client acknowledges and accepts that the supply of Goods for accepted orders may be subject to availability and if, for any reason, Goods are not or cease to be available, SIA reserves the right to vary the Price with alternative Goods as per clause 6.2
- 2.6 Notwithstanding clause 2.5 SIA also reverses the right at their discretion to introduce additional new Goods as part of the Goods to be supplied.
- 2.7 These terms and conditions are meant to be read in conjunction with the Terms and Conditions posted on SIA's website. If there are any inconsistencies between the two documents then the terms and conditions contained in this document shall prevail.

3. Distribution of Goods via an Approved Retailers

- 3.1 The Client agrees that until they are authorised as a retailer by SIA, (and hereinafter the Client shall be referred to as "Retailer" for the purposes of this clause) the Retailer shall not be able to sell the Goods on as a Retailer for SIA or represent to any third parties that the Retailer is in any way acting for SIA. SIA shall not accept responsibility or agree to be bound in any way by any contracts with third parties to whom the Retailer is a party.
- 3.2 At SIA's sole discretion the Retailer acknowledges that only approved Retailers shall have the authority to accept internet orders via their respective website and/or any alternative online auction sites.

- 3.4 Any default of clauses 3.1-3.3 may at SIA's sole discretion be subject to immediate and permanent closure of account facilities, with any account balances payable immediately on demand.
- 3.5 SIA has sole discretion on which brands or Goods are made available to any approved Retailer and SIA does not guarantee continuing supply of any specific brand or Goods.

4. Electronic Transactions (Victoria) Act 2000

4.1 Electronic signatures shall be deemed to be accepted by either party providing that the parties have complied with Section 9 of the Electronic Transactions (Victoria) Act 2000 or any other applicable provisions of that Act or any Regulations referred to in that Act.

5. Change in Control

1 The Client shall give SIA not less than fourteen (14) days prior written notice of any proposed change of ownership of the Client and/or any other change in the Client's details (including but not limited to, changes in the Client's name, address, contact phone or fax number/s, or business practice). The Client shall be liable for any loss incurred by SIA as a result of the Client's failure to comply with this clause.

6. Price and Payment

- At SIA's sole discretion, the Price shall be either:
 - (a) as indicated on any invoice provided by SIA to the Client; or
 - (b) the Price as at the date of delivery of the Goods according to SIA's current price list; or
 - (c) SIA's quoted price (subject to clause 6.2) which will be valid for the period stated in the quotation or otherwise for a period of thirty (30) days.
- SIA reserves the right to change the Price if a variation to SIA's quotation is requested. - (c) Goods supplied may exhibit variations in shade, colour, texture, surface and finish, and may fade or change colour over time. SIA accepts no responsibility for any loss, damages, or costs however resulting from the Client's failure to comply with this clause.

10. Access

10.1 The Client shall ensure that SIA has clear and free access to the work site at all times to enable them to undertake the Services. SIA shall not be liable for any loss or damage to the site (including, without limitation, damage to pathways, driveways and concreted or paved or grassed areas) unless due to the negligence of SIA.

11. Title

- 11.1 SIA and the Client agree that ownership of the Goods shall not pass until:
 - (a) the Client has paid SIA all amounts owing to SIA; and
 - (b) the Client has met all of its other obligations to SIA.
- 11.2 Receipt by SIA of any form of payment other than cash shall not be deemed to be payment until that form of payment has been honoured, cleared or recognised.

 - (c) the Client must not sell, dispose, or otherwise part with possession of the Goods other than in the ordinary course of business and for market value. If the Client sells, disposes or parts with possession of the Goods then the Client must hold the proceeds of any such act on trust for SIA and must pay or deliver the proceeds to SIA on demand.
 - (d) the Client should not convert or process the Goods or intermix them with other goods but if the Client does so then the Client holds the resulting product on trust for the benefit of SIA and must sell, dispose of or return the resulting product to SIA as it so directs.
 - (e) the Client irrevocably authorises SIA to enter any premises where SIA believes the Goods are kept and recover possession of the Goods.
 - (f) SIA may recover possession of any Goods in transit whether or not delivery has occurred.
 - (g) the Client shall not charge or grant an encumbrance over the Goods nor grant nor otherwise give away any interest in the Goods while they remain the property of SIA.
 - (h) SIA may commence proceedings to recover the Price of the Goods sold notwithstanding that ownership of the Goods has not passed to the Client.

12. Personal Property Securities Act 2009 ("PPSA")

- 12.1 In this clause financing statement, financing change statement, security agreement, and security interest has the meaning given to it by the PPSA.
- 12.2 Upon assenting to these terms and conditions in writing the Client acknowledges and agrees that these terms and conditions constitute a security agreement for the purposes of the PPSA and creates a security interest in all Goods and/or collateral (account) being a monetary obligation of the Client to SIA for Services that have previously been supplied and that will be supplied in the future by SIA to the Client.
- 12.3 The Client undertakes to:
 - (a) promptly sign any further documents and/or provide any further information (such information to be complete, accurate and up-to-date in all respects) which SIA may reasonably require to;
 - register a financing statement or financing change statement in relation to a security interest on the Personal Property Securities Register;
 - (ii) register any other document required to be registered by the PPSA; or
 - (iii) correct a defect in a statement referred to in clause 12.3(a)(i) or 12.3(a)(ii);
 - (b) indemnify, and upon demand reimburse, SIA for all expenses incurred in registering a financing statement or financing change statement on the Personal Property Securities Register established by the PPSA or releasing any Goods charged thereby:
 - (c) not register a financing change statement in respect of a security interest without the prior written consent of SIA;
 - (d) not register, or permit to be registered, a financing statement or a financing change statement in relation to the Goods and/or collateral (account) in favour of a third party without the prior written consent of SIA;
 - (e) immediately advise SIA of any material change in its business practices of selling the Goods which would result in a change in the nature of proceeds derived from such sales.
- 12.4 SIA and the Client agree that sections 96, 115 and 125 of the PPSA do not apply to the security agreement created by these terms and conditions.

- 12.7 Unless otherwise agreed to in writing by SIA, the Client waives their right to receive a verification statement in accordance with section 157 of the PPSA.
- 12.8 The Client must unconditionally ratify any actions taken by SIA under clauses 12.3 to 12.5.
- 12.9 Subject to any express provisions to the contrary (including those contained in this clause 12) nothing in these terms and conditions is intended to have the effect of contracting out of any of the provisions of the PPSA.

13. Security and Charge

- 13.1 In consideration of SIA agreeing to supply the Goods, the Client charges all of its rights, title and interest (whether joint or several) in any land, realty or other assets capable of being charged, owned by the Client either now or in the future, to secure the performance by the Client of its obligations under these terms and conditions (including, but not limited to, the payment of any money).
- 13.2 The Client indemnifies SIA from and against all SIA's costs and disbursements including legal costs on a solicitor and own client basis incurred in exercising SIA's rights under this clause.
- 13.3 The Client irrevocably appoints SIA and each director of SIA as the Client's true and lawful attorney/s to perform all necessary acts to give effect to the provisions of this clause 13 including, but not limited to, signing any document on the Client's behalf.

14. Defects, Warranties and Returns, Competition and Consumer Act 2010 (CCA)

- 14.1 The Client must inspect the Goods on delivery and must within three (3) days of delivery notify SIA in writing of any evident defect/damage, shortage in quantity, or failure to comply with the description or quote. The Client must notify any other alleged defect in the Goods as soon as reasonably possible after any such defect becomes evident. Upon such notification the Client must allow SIA to inspect the Goods.
- 14.2 Under applicable State, Territory and Commonwealth Law (including, without limitation the CCA), certain statutory implied guarantees and warranties (including, without limitation the statutory guarantees under the CCA) may be implied into these terms and conditions (Non-Excluded Guarantees).
- 14.3 SIA acknowledges that nothing in these terms and conditions purports to modify or exclude the Non-Excluded Guarantees.
- 14.4 Except as expressly set out in these terms and conditions or in respect of the Non-Excluded Guarantees, SIA makes no warranties or other representations under these terms and conditions including but not limited to the quality or suitability of the Goods. SIA's liability in respect of these warranties is limited to the fullest extent permitted by law.
- 14.5 If the Client is a consumer within the meaning of the CCA, SIA's liability is limited to the extent permitted by section 64A of Schedule 2.
- 14.6 If SIA is required to replace the Goods under this clause or the CCA, but is unable to do so, SIA may refund any money the Client has paid for the Goods.
- 14.7 If the Client is not a consumer within the meaning of the CCA, SIA's liability for any defect or damage in the Goods is:
 - (a) limited to the value of any express warranty or warranty card provided to the Client by SIA at SIA's sole discretion;
 - (b) limited to any warranty to which SIA is entitled, if SIA did not manufacture the Goods;
 - (c) otherwise negated absolutely.
- 14.8 Subject to this clause 14, returns will only be accepted provided that:
 - (a) the Client has complied with the provisions of clause 14.1; and
 - (b) SIA has agreed that the Goods are defective; and
 - (c) the Goods are returned within a reasonable time at the Client's cost (if that cost is not significant); and
 - (d) the Goods are returned in as close a condition to that in which they were delivered as is possible.
- 14.9 Notwithstanding clauses 14.1 to 14.8 but subject to the CCA, SIA shall not be liable for any defect or damage which may be caused or partly caused by or arise as a result of:
 - (a) the Client failing to properly maintain or store any Goods;
 - (b) the Client using the Goods for any purpose other than that for which they were designed;
 - (c) the Client continuing the use of any Goods after any defect became apparent or should have become apparent to a reasonably prudent operator or user;
 - (d) the Client failing to follow any instructions or guidelines provided by SIA;
 - (e) fair wear and tear, any accident, or act of God.
- 14.10 Notwithstanding anything contained in this clause if SIA is required by a law to accept a return then SIA will only accept a return on the conditions imposed by that law.

15. Intellectual Property

- 15.1 Where SIA has designed, drawn or developed Goods for the Client, then the copyright in any designs and drawings and documents shall remain the property of SIA. Under no circumstances may such designs, drawings and documents be used without the express written approval of SIA.
- 15.2 The Client warrants that all designs, specifications or instructions given to SIA will not cause SIA to infringe any patent, registered design or trademark in the execution of the Client's order and the Client agrees to indemnify SIA against any action taken by a third party against SIA in respect of any such infringement.
- 15.3 The Client agrees that SIA may (at no cost) use for the purposes of marketing or entry into any competition, any documents, designs, drawings or Goods which SIA has created for the Client.

16. Default and Consequences of Default

16.1 Interest on overdue invoices shall accrue daily from the date when payment becomes due, until the date of payment, at a rate of two and a half percent (2.5%) per calendar month (and at SIA's sole discretion such interest shall compound monthly at such a rate) after as well as before any judgment.

 - (c) the Client becomes insolvent, convenes a meeting with its creditors or proposes or enters into an arrangement with creditors, or makes an assignment for the benefit of its creditors; or
 - (d) a receiver, manager, liquidator (provisional or otherwise) or similar person is appointed in respect of the Client or any asset of the Client.

17. Cancellation

- 17.1 Without prejudice to any other remedies SIA may have, if at any time the Client is in breach of any obligation (including those relating to payment) under these terms and conditions SIA may suspend or terminate the supply of Goods to the Client. SIA will not be liable to the Client for any loss or damage the Client suffers because SIA has exercised its rights under this clause.
- 17.2 SIA may cancel any contract to which these terms and conditions apply or cancel delivery of Goods at any time before the Goods are delivered by giving written notice to the Client. On giving such notice SIA shall repay to the Client any money paid by the Client for the Goods. SIA shall not be liable for any loss or damage whatsoever arising from such cancellation.

- 17.4 Cancellation of orders for Goods made to the Client's specifications, or for non-stocklist items, will definitely not be accepted once production has commenced, or an order has been placed.

18. Dispute Resolution

- 18.1 If a dispute arises between the parties to this contract then either party shall send to the other party a notice of dispute in writing adequately identifying and providing details of the dispute. Within fourteen (14) days after service of a notice of dispute, the parties shall confer at least once, to attempt to resolve the dispute. At any such conference each party shall be represented by a person having authority to agree to a resolution of the dispute. In the event that the dispute cannot be so resolved either party may by further notice in writing delivered by hand or sent by certified mail to the other party refer such dispute to arbitration. Any arbitration shall be:
 - (a) referred to a single arbitrator to be nominated by the President of the Institute of Arbitrators Australia; and
 - (b) conducted in accordance with the Institute of Arbitrators Australia Rules for the Conduct of Commercial Arbitration.

19. Privacy Act 1988

- 19.1 The Client agrees for SIA to obtain from a credit reporting body (CRB) a credit report containing personal credit information (e.g. name, address, D.O.B, occupation, previous credit applications, credit history) about the Client in relation to credit provided by SIA.
- 19.2 The Client agrees that SIA may exchange information about the Client with those credit providers and with related body corporates for the following purposes:
 - (a) to assess an application by the Client; and/or
 - (b) to notify other credit providers of a default by the Client, and/or
 - (c) to exchange information with other credit providers as to the status of this credit account, where the Client is in default with other credit providers; and/or
 - (d) to assess the creditworthiness of the Client including the Client's repayment history in the preceding two years.
- 19.3 The Client consents to SIA being given a consumer credit report to collect overdue payment on commercial credit.
- 19.4 The Client agrees that personal credit information provided may be used and retained by SIA for the following purposes (and for other agreed purposes or required by):
 - (a) the provision of Goods; and/or
 - (b) analysing, verifying and/or checking the Client's credit, payment and/or status in relation to the provision of Goods; and/or
 - (c) processing of any payment instructions, direct debit facilities and/or credit facilities requested by the Client; and/or
 - (d) enabling the collection of amounts outstanding in relation to the Goods.
- 19.5 SIA may give information about the Client to a CRB for the following purposes:
 - (a) to obtain a consumer credit report;
 - (b) allow the CRB to create or maintain a credit information file about the Client including credit history.
- 19.6 The information given to the CRB may include:
 - (a) personal information as outlined in 19.1 above;
 - (b) name of the credit provider and that SIA is a current credit provider to the Client,
 - (c) whether the credit provider is a licensee;
 - (d) type of consumer credit.
 - (e) details concerning the Client's application for credit or commercial credit (e.g. date of commencement/termination of the credit account and the amount requested);
 - (f) advice of consumer credit defaults, overdue accounts, loan repayments or outstanding monies which are overdue by more than sixty (60) days and for which written notice for request of payment has been made and debt recovery action

- commenced or alternatively that the Client no longer has any overdue accounts and SIA has been paid or otherwise discharged and all details surrounding that discharge (e.g. dates of payments);
- (g) information that, in the opinion of SIA, the Client has committed a serious credit infringement;
- (h) advice that the amount of the Client's overdue payment is equal to or more than one hundred and fifty dollars (\$150).
- 19.7 The Client shall have the right to request (by e-mail) from SIA:
 - (a) a copy of the information about the Client retained by SIA and the right to request that SIA correct any incorrect information; and
 - (b) that SIA does not disclose any personal information about the Client for the purpose of direct marketing.
- 19.8 SIA will destroy personal information upon the Client's request (by e-mail) or if it is no longer required unless it is required in order to fulfil the obligations of this agreement or is required to be maintained and/or stored in accordance with the law.
- 19.9 The Client can make a privacy complaint by contacting SIA via e-mail. SIA will respond to that complaint within seven (7) days of receipt and will take all reasonable steps to make a decision as to the complaint within thirty (30) days of receipt of the complaint. In the event that the Client is not satisfied with the resolution provided, the Client can make a complaint to the Information Commissioner at www.oaic.gov.au.

20. Service of Notices

- 20.1 Any written notice given under this contract shall be deemed to have been given and received:
 - (a) by handing the notice to the other party, in person:
 - (b) by leaving it at the address of the other party as stated in this contract
 - (c) by sending it by registered post to the address of the other party as stated in this contract;
 - (d) if sent by facsimile transmission to the fax number of the other party as stated in this contract (if any), on receipt of confirmation of the transmission:
 - (e) if sent by email to the other party's last known email address.
- 20.2 Any notice that is posted shall be deemed to have been served, unless the contrary is shown, at the time when by the ordinary course of post, the notice would have been delivered.

21 Genera

- 21.1 The failure by either party to enforce any provision of these terms and conditions shall not be treated as a waiver of that provision, nor shall it affect that party's right to subsequently enforce that provision. If any provision of these terms and conditions shall be invalid, void, illegal or unenforceable the validity, existence, legality and enforceability of the remaining provisions shall not be affected, prejudiced or impaired.
- 21.2 These terms and conditions and any contract to which they apply shall be governed by the laws of Victoria, the state in which SIA has its principal place of business, and are subject to the jurisdiction of the Melbourne Courts in Victoria.
- 21.3 Subject to clause 14 SIA shall be under no liability whatsoever to the Client for any indirect and/or consequential loss and/or expense (including loss of profit) suffered by the Client arising out of a breach by SIA of these terms and conditions (alternatively SIA's liability shall be limited to damages which under no circumstances shall exceed the Price of the Goods).
- 21.4 Neither party shall assign or sub-contract all or any part of their rights and obligations under this agreement without the written consent of the other party.
- 21.5 The Client agrees that SIA may amend these terms and conditions by notifying the Client in writing. These changes shall be deemed to take effect from the date on which the Client accepts such changes, or otherwise at such time as the Client makes a further request for SIA to provide Goods to the Client.
- 21.6 Neither party shall be liable for any default due to any act of God, war, terrorism, strike, lock-out, industrial action, fire, flood, storm or other event beyond the reasonable control of either party.
- 21.7 Both parties warrant that they have the power to enter into this agreement and have obtained all necessary authorisations to allow them to do so, they are not insolvent and that this agreement creates binding and valid legal obligations on them.
